Ft. (Built Up area), on Ground Floor, in Charandas Apartment, Situated on Wing No. 2, Room No. 589, Block No. A - 99, Ulhasnagar - 2 Dist. Thane, Assessed Under Ward No. 15, Khata No. 1234.

AND TO HAVE TO HOLD the said property and hereditments and/or premises hereby gifted unto and to the use of the said Donee forever and absolutely.

AND WHEREAS the said Donee shall may from time to time and at all time hereafter peacefully and quietly enter upon to hold possess, occupy absolutely enjoy without obstruction and hindrances whatsoever from or by the Donor or by any persons claiming by under and from her.


